REQUIREMENTS FOR AMENDMENT OF PASSPORT

- 1. Valid passport and one (1) photocopy of passport data page
- 2. Duly accomplished application form signed by the applicant (Form is available on the Philippine Embassy website, www.philembassydhaka.org for downloading)
- 3. Processing fee of Tk 1,700.00

In the following cases, applicant should submit other documents in addition to the requirements above-stated:

For **female applicant** who wishes to change her **maiden name** TO **married name** in her current passport,

4. one (1) original or certified true copy and one (1) photocopy of Marriage Contract duly authenticated by the Philippine National Statistics Office (NSO) on Security Paper or Report of Marriage if married abroad.

For **female applicant** who wishes to change her **married name** TO **maiden name due** to the **death of the spouse**,

- 5. Duly authenticated death certificate or the Court Order in case of presumptive death; and
- 6. Documentary proof of middle name

For **female applicant** who wishes to change FROM **married name** TO **maiden name due** to **annulment or divorce** (provided the conditions surrounding the divorce are recognized under Philippine law),

- 7. Documentary proof of middle name; and
- 8. Duly authenticated copy of the annulment/divorce decree or order
